In the Town of La Jara there is an ordinance that all dogs are required to be registered with us and are to be within your property. Any dog that is out will be picked up and a fine will be in imposed to the owner. If the dog is not claimed it will be sent to San Luis Animal Shelter.

Section 5: Dogs Running At Large

a) It shall be unlawful for any owner or harborer of any dog in the Town of La Jara to permit the same to run at large within the Town. A dog shall be deemed to be running at large when off or away from the premises of the owner, possessor or keeper thereof and not under the control of such owner, possessor or harborer or his agent, servant, or a member of his immediate family, either by leash, cord, chain, not more than ten (10) feet in length.

Snowy Months

We would like to inform all business owners, home owners, and property owners that when we get snow it is your responsibility to clean all snow within your frontages; our maintaince is not responsible to clean your sidewalks, driveways, or any form of frontages that are owned by you. Starting December 1st any snow on sidewalks in front of your business will no longer be maintained by our maintaince unless an agreement was made with our Town Manager and Maintaince Supervisor.

Section 10: Safety Provisions

a) Interference with Officers: It shall be unlawful for any person to interfere with, molest, hinder or obstruct the police officer, pound master, or any other person duly authorized to perform official duties under this Ordinance.

b) Penalties: Any person who violates any of the provisions of this Ordinance shall be guilty of a misdemeanor, and upon conviction thereof, shall be punished according to the following

- - the charge of permitting a dog to run at large within a 12 month period, order the dog to be destroyed as a public nuisance or order the dog to be set for adoption by anyone except a resident of the Town of La Jara. \$40.00
- Failure To Have a Dog Vaccinated Against Rabies. 111
- Failure to Register and License the Dog With the Town Clerk....\$40.00 Failure to Place Collar and Registration Tag Upon the Dog......\$20.00 Unlawful Removal of Dog from Town Pound......\$500.00 ..\$500.00
- Salure to Produce the Dog Reported as Having Inflicted a Bite...\$200.00 Keeping or Harboring a Dog which is a Nuisance......\$100.00 Over Limit of Three Dogs Per Residence Per Dog......\$250.00
- ...\$25.00
- Keeping or Harboring a Vicious Dog in Violation of the Provisions of this Ordinance as Herein Provided, a Fine Not to Exceed \$500.00 or By Confinement in Jail for Not More than 30 days, or By Both Such Fine and Imprisonment.
- Second Offence and All Subsequent Offences for Keeping or Harboring a Vicious Dog Shall Be a \$1000.00 Fine and Confinement in Jail for Not Less Than 5 Days or More than 30 Days in Jail.
- Violation of Any Other Provision of this Ordinance Not Specifically Set Forth in Section (b)(i) through (x) Inclusive: A Fine Not to Exceed \$500.00 or By Confir No More than 30 days, or By Both Such Fine and Imprisonment.
