Nuisance Ordinance

Ordinance 1975-8 (section 2)

Removal of weeds, brush junk, and public nuisances--required time-It is hereby made the duty of every owner of real property in the Town of La Jara to remove all weeds, brush, junk of all kinds and structures which constitutes a public nuisance or which may constitute a health hazard or are dangerous and hazardous to the safety of persons and property from lots and tracts of land within the Town of La Jara, and from the alleys behind and from sidewalk areas in front of such property at least once each year in accordance with a time notice provided, or at any such time as such owner or real property is ordered or directed by any fire or police chief, or by the Board of Trustees under the Provisions of Section 7 (a).

Important Update

The Town of La Jara is presently in the process of revising the Chapter 91 Nuisance Ordnance that is posted above. Throughout the remainder of the year (2023) The Board of Trustees, Town Manager, and Chief of Police will be contacting residents that may be in violation of the nuisance ordinance. Our desire is to work with violators of the ordinance and formulate a plan to work together with residents, or business owners to come into compliance with the Nuisance Ordinance. Contact will be made via letters further explaining the Nuisance Ordinance in the near future.

No Outside Burning

Ordinance 1997-1 (section 2&3)

Section 2- Outside Burning Prohibited: No person shall kindle or maintain any bonfire or burn or permit to be burned any trash, refuse, wood, weeds, brush, plants or other combustible or flammable material anywhere within the limits of the Town of La Jara or anywhere on town property outside of the town limits, except when:

(1) The burning is in the course of an agricultural

- (1) The burning is in the course of an agricultural operation in the growing of crops as a gainful occupation and presents no fire hazards to other property in the vicinity:
- (2) The burning is for the noncommercial cooking of food for human beings:
- (3) The burning is a smokeless flare or a safety flare used to indicate some danger to the public, or:
- (4) The burning is a training fire conducted by the Fire Department, or a training fire conducted by another fire department and approved in writing by the Town's Fire Marshall.
