WHEREAS, the Town now finds it necessary to make a transfer within the budget not foreseen at the time the budget was adopted; and,


WHEREAS, the Board of Trustees of the Town of La Jara finds it necessary to transfer within the budget in accordance with the law.


WHEREAS, the Town now finds it necessary to make a transfer within the budget not foreseen at the time the budget was adopted; and,
