

RESOLUTION NO. 1975-4

A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 1975, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF LA JARA, COLORADO, FOR THE 1976 BUDGET YEAR.

WHEREAS, the Board of Trustees of the Town of La Jara is in the process of adopting the annual budget in accordance with the Local Government Budget Law, and;

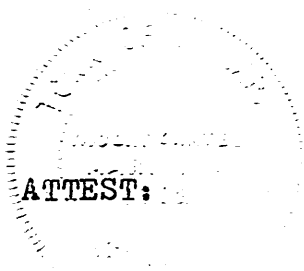
WHEREAS, the amount of money necessary to balance the budget for general operating expenses is \$ 13,951.00, and;

WHEREAS, the 1975 valuation for assessment for the Town of La Jara, as certified by the County Assessor is \$ 727,005.00.  
NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LA JARA, COLORADO:

Section 1. That for the purpose of meeting all general operating expenses of the Town of La Jara during the 1976 budget year, there is hereby levied a tax of 19.19 mills upon each dollar of the total valuation for assessment of all taxable property within the Town for the year 1975.

Section 2. That the TOWN CLERK is hereby authorized and directed to immediately certify to the County Commissioners of Conejos County, Colorado, the mill levies for the Town of La Jara as hereinabove determined and set.

WHEREAS, the Board of Trustees of the Town of La Jara is in the process of adopting the annual budget in accordance with the local Government Budget Law, and;
