

RESOLUTION 1983-2

A RESOLUTION TO ENTER INTO A CONTRACT WITH THE CONEJOS-COSTILLA COMMUNITY ACTION AGENCY, INCORPORATED, FOR THE PURPOSE OF ALLOWING IT TO RENDER CERTAIN TECHNICAL ASSISTANCE SERVICES IN CONNECTION WITH THE TOWN'S COMMUNITY DEVELOPMENT BLOCK GRANT PROJECT AND TO AUTHORIZE THE MAYOR AND THE TOWN CLERK TO SIGN SAID CONTRACT, FOR AND IN BEHALF OF THE TOWN OF LA JARA, COLORADO

WHEREAS, in the opinion of the Board of Trustees of the Town of La Jara, it is necessary and desirable to participate in a Community Development Block Grant program as established by the United States Government with the Housing and Community Development Act of 1974, Publication L, No. 93-383, as amended, as such will be administered by the State of Colorado through the Colorado Department of Local Affairs, Division of Local Government, Division of Commerce and Development and Division of Housing, pursuant to C.R.S. (1973) §24-32-106(1)(d), §24-32-304(2)(j), and §24-32-705(1)(i); and

WHEREAS, the Board of Trustees finds it necessary to engage a consultant to render certain technical assistance services in connection with its Community Development Program; and

WHEREAS, the Conejos-Costilla Community Action Agency, Inc. possesses the necessary qualifications and employs qualified personnel necessary and as required to render certain technical assistance services in connection with the Community Development Program; and

WHEREAS, the Conejos-Costilla Community Action Agency, Inc. is desirous of rendering such services pursuant to a written agreement to be executed by it and the Town of La Jara,

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of La Jara, Colorado, as follows:

Section 1. That the Board of Trustees of the Town of La Jara has appointed, and by this Resolution, appoints the Mayor of the Town of La Jara and the La Jara Town Clerk to sign the Contractual Agreement, a copy of which is attached hereto as Exhibit "A" and by this reference made a part hereof as if set forth in full herein, giving unto said Mayor and Town Clerk full power and authority so to do, and the Board of Trustees does hereby ratify and confirm the signing of said contract lawfully done pursuant to the authority hereby conferred upon them.
