The La Jara maintenance crew started the demo of the old maintaince budling early August. Without the help of local citizens assisting in taking materials that they could use we would still have a lot to clean up. We would like to give a big thank you to those who have assisted with the clean up and we are greatly appreciative of the help.

TOWN OF LA JARA 4-DAY WORK WEEK PROPOSAL

- The proposal was to operate on a 4-day schedule with hours of Monday thru Thursday from 7:30 am to 5:30 pm. A 30-minute lunch period from 12:00 to 12:30 and no closure of Town Hall. Clerks would rotate their individual lunch time.
- Employees would continue to work a 40-hour work week, working 10 hours per day; overtime will be given for any hours worked over 40 hours per week.
- The new schedule would allow continual access to town for a total of 10 hours.Town Hall would be open during the lunch hour. This would provide more hours of service from Monday thru Thursday.
- Investing in online billing options to allow citizens to pay bills without having to call in or visit Town Hall.
- During the 2023-2024 calendar year the majority of the Federal Holidays fall on days other than Friday. Employees will be given a paid holiday or compensation if required to work on the holiday. If the holiday occurs Monday through Thursday, the missed day of work will not be made up. There are only two Friday Holidays.
- •Several weeks during a calendar year the Town Clerk, Maintenance workers, and Town Manager are working beyond a 40-hour week.
- A 4-day work week is becoming a typical practice for many municipalities and school districts. Valley municipalities that have made the transition include Del Norte, Monte Vista, Rio Grande County, Center (4 ½ day), San Luis, and Alamosa. Every school in the San Luis Valley is now on a 4-day week.
- This being an increasing practice supports the need for "work/life" balance.
- Some general benefits for a 4-day work week:

 Provide more hours of service for the public.
 Increased productivity by employees
 Possibility of lowering utility costs

SEPTEMBER 2023

- Educating the public will be needed if the 4-day work week is employed. It will require the support of all employees and Board Trustees to assist with the educating of the public. Once the public is advised they "will learn and adjust" to the Friday closures.
- Keep in mind that Friday's are typically slow in the office, most often 1-2 walk-ins and very few calls to pay bills.
- Maintenance staff will be on call Friday through Sunday for water/sewer emergencies.
- The 4-day work schedule excludes the police department as they set their own schedule.
